

## Northridge Subdivision Architectural Improvements Application

This application process is in accordance with the Declaration of Covenants, Conditions and Restrictions (CC&R's) and Design Guidelines for North Ridge Subdivision. Homeowners are required to be familiar with these documents and to comply with them.

### Instructions:

This is to assist the Homeowner in ensuring the application submittal includes all information necessary for a thorough review process.

Projects include, but are not limited to the following:

- New construction, including site building and architectural guidelines.
- Building structure, forms, and materials, including windows and doors.
- Landscape design and materials.
- Retaining walls, landscape walls, and fences
- Porches, balconies, and decks
- Fireplace, chimneys, vents, flues, and gutters
- Skylights and solar panels

Before work on the project begins, the Homeowner must supply the DRC with a copy of:

- Sketch Plan (to include Lot Lines)
- Landscape and Irrigation Plan
- Material Specification List (Type, style, color)
- DRC Fee/Deposit

Kindly, complete the attached application form in its entirety. The DRC will use the information provided to evaluate your application. Applications are typically reviewed within thirty (30) days of submittal. Approved projects not completed within one (1) year of application require are required to resubmit an application for approval. Fees are non-refundable. Changes may result in the loss of deposit.

### Fee Schedule

The Northridge Subdivision Design Review Committee has established this fee schedule in order to maintain design standards and ensure a harmonious residential experience.

#### **Minor Projects** (including fence installation, exterior modification)

- Design Review Fee - \$150

#### **New Construction** (including new landscaping and irrigation)

- Design Review Fee - \$500
- Construction Damage Deposit - \$1500
- Landscaping/Irrigation Deposit - \$1000
